### Course Description for R25/24

**START** on unclassified road just off Resolven roundabout, access to TSW works, 16 yards north of R10/22 start point. Proceed to Resolven roundabout, (0.102 miles) taking 1st exit left southbound on A465 dual carriageway to Aberdulais interchange (4.427 miles) Bear left up around the loop to Tonna roundabout (4.909 miles). Take 1st exit left to main interchange roundabout (4.967 miles), circle roundabout to take 4th exit left down slip road to rejoin A465 northbound (5.363 miles). Proceed northwards to Resolven roundabout (9.562 miles), continue on A465 dual carriageway to Blaengwrach roundabout (12.599 miles). Take 1st left along cross-valley link to junction with B4242 (12.818 miles). Bear left along B4242 southbound via Pentreclwdau to Resolven junction. Continue south on B4242 via Ynysarwed, Rock & Fountain to Turn at break in dual carriageway at Ynysgerwen (opposite factories entrance) (19.568 miles). Retrace to Resolven junction (23.050 miles). Continue on B4242 passing Rheola pond to **FINISH** at 25 yards beyond 'Ffermdy Pentreclwydau' in disused access (opposite start of R10/23) 25.014 miles).

### All riders are asked to comply with the following requests

To assist the timekeepers and other officials, riders from each team should wear similar jerseys

**DO NOT** park or stop your car within sight of the starting or finishing timekeeper.

**DO NOT** leave your number flapping - four pins are supplied for each - **USE THEM**

**DO NOT** allow your friends and relations to follow you around the course - it's not allowed.

**DO** call your number to the finishing timekeeper or your time may not be recorded.

**DO** keep your head up, be aware of your surroundings and **HAVE A SAFE RIDE**

### Important Notice to all Riders

The WCA, CTT and Police all recommend the use of a good hard shell helmet manufactured to internationally recognised standards.

For ALL Riders under the age of 18 these helmets are **COMPULSORY**.

Marshall's will be positioned around the course they are there to show you the way but they have no authority over the traffic.

Please note we are not allowed to place direction arrows on the Dual Carriageway, please ensure you are familiar with the course, so there are no surprises. It is the Riders responsibility to ride within the laws of the road and with consideration to other road users so please do so
