1. Highway Maintenance Community Enhancement Fund

As you are effectively using a contractor, by employing somebody to carry out this work, we are only able to provide a contribution of up to 50%. We would therefore be able to match the parish council's contribution of $\pounds 250.00$.

2. The Clerk received the following email from a parishioner; - I have recently moved into Chapel Street in Bere Alston. As with many areas in the village there are difficulties with parking. I have appealed to the Highway agency to have a keep clear sign re-painted on the road opposite our driveway which is consistently blocked and actually provides access to off- road parking for three houses and four cars thus actually alleviating the parking issue.

I have been informed that the restriction needs to be passed through the local parish before it can be approved and was wondering what would be the best way to state our case and support our application. Any information would be gratefully received. Cllr. Lamb to action.
