Discussions then took place with regards to upgrading the photo copier to a coloured one and link it to the internet, or purchase an A3 laser printer at a cost of approximately £250.

Cllr. Lamb proposed that this committee recommend to Finance and General Purposes that they purchase a laser printer to be able to have a hard copy of the drawings, seconded by Cllr. Crozier.

3200. Report on Road Warden Scheme.

Cllr. Maycock has no report. Cllr. Lamb brought forward the request from Devon County asking for a summary of the £1,000 grant and what it was spent on. Also possibly some photographs of the work being carried out. There was a suggestion from Full Council that this money be carried forward to purchase a road sign for the junction of Pentillie and Cornwall Street.

Correspondence.

 Vicki Lloyd on behalf of the Youth Shelter Group Vicki has received an email from Awards For All regarding their application for a £10,000 grant for the shelter. Asking if they have a 5 year lease on the land, also are they sure they have the right planning approval.
Discussions took place and it was agreed to recommend to Full Council that they look into drawing a lease up for 5 years for the land the shelter stands on.
A vote was taken 7 for the proposal of a lease 1 against.
Council will in due course conclude the lease.
Clerk to confirm with Vicki that they need this in writing.

There being no further business the Chairman thanked members for attending and declared the meeting closed at 8.02pm.
