117. Enforcement cases to be taken in part 2.

<u>118. To discuss 13 Fore Street, Bere Alston.</u>

Cllr. Lamb stated that many people have taken this matter up with West Devon; the following are their replies:

"In relation to 13 Fore Street, Bere Alston, I am awaiting the following information:

- Details of any planning applications made from the planning department
- Details of electoral register for the property from West Devon Elections

The land registry search showed the land to be unregistered.

I am visiting on Monday morning to complete an empty property survey, take photographs, and speak to neighbours and local residents to ascertain ownership."

"Thank you kindly for the additional information. I visited the property last week and I am awaiting David Sexton's return tomorrow from annual leave to discuss the best course of action.

Katy Gibb, a previous colleague who has now left the council was investigating the case from 2016 onwards and I am reviewing contact between her and the owner's solicitor received in October 2018 (after Katy left) which can be taken into consideration also. It claims the owner works at the Victoria and Albert museum in London and lives rent for free in a room nearby at the grace of a friend who is a previous employee of V&A museum; is working to improve his financial position for retirement to the property in Bere Alston and that he is 70+."

"I have discussed the case again with Dave Sexton, Senior Environmental Health Specialist in the Private Sector Housing Team and he has confirmed that due to a shortage of Specialists in Environmental Health we are unable to carry out enforcement on empty homes at the current time – unless they are impacting the structure of neighbouring properties or causing a pest issue – we may then use powers under the Environmental Protection Act 1990 to improve conditions.

We have advised the owner of 13 Fore Street, Bere Alston on the loans available from Wessex and council letting options; and also discussed assistance from empty homes specialist company Grafton's.

I am sorry that we are not able to take further action at this time."

<u>119. Report from Road Wardens.</u>

Cllr. Lamb informed the committee that Cllr. Hanson has resigned as co-ordinator for the Road Wardens.

Discussions took place with regards to the County Highways road markings for future work. It is noted that the back road to Tavistock (Shillamill) has been marked out for minimal pot hole repairs and yet the Denham Bridge Road which could be dangerous for motor bikes in the dark has had no work indicated.
