### Significant Changes to Red Tractor Dairy Standards

New issues are emerging all the time, not only in the agricultural industry, but also in the minds of consumers who buy Red Tractor branded products.

**The Dairy Standards will incur significant changes from October 2019.** These changes will strengthen standards in some areas, providing positive reassurance to consumers and milk buyers on some key issues. It is well documented that an outbreak of disease can be devastating to individual farmers and the whole industry. Consequently the dairy industry is always working hard to ensure the health of individual herds, and, in turn, to improve the health of the national herd.



#### The main changes are as follows:

**Section 1: The Health Plan:** A livestock Health Plan, **written in conjunction with your vet**, to proactively manage and improve health and welfare of livestock must be established and implemented. The Health Plan must be used as an active document on farm and will include protocols for: biosecurity policy, infectious disease and vaccination, parasite control, foot care and lameness management, mastitis, metabolic disorders, management of drying off, calving procedures, husbandry procedures, identifying treated animals, pain relief procedures, dealing with TB reactors, downer cows, use of shackles/hobbles and euthanasia.

**Section 2: Pain Relief:** Pain relief must be provided (and recorded) to all animals that are likely to be in pain due to a health condition, injury or potentially painful procedures.

**Section 3: Disease Control:** Two compulsory standards re: disease control have been added, which will require farmers to determine their herd/animal status and how the farm is managing the disease risk posed by Johne's and BVD:

- (a) Johne's disease must be managed through the implementation of the National Johne's Management Plan.
- (b) BVD must be managed through a BVD eradication programme designed in conjunction with the farm vet. Eradication programme may include participation in a national scheme (BVDFree England) or membership of CHeCS accredited scheme

## Significant Changes to Red Tractor Dairy Standards contd...

**Section 4: Vet Antibiotic Review:** Includes review of any Cascade or off-label use and recommendations for alternative disease prevention strategies.

**Section 5: Medicine Administration Records:** Teat sealant also needs to be recorded.

**Section 7: Colostrum Management:** Colostrum or milk from known Johnes positive cows must be identified with an alternative provision for calves detailed in health plan (e.g. frozen colostrum from clean cows/powdered colostrum).

**Section 8: Medicine Administration:** At least one person who is responsible for administering medicines has undertaken training, and holds a certificate of competence/attendance since October 2016. Training courses include MilkSure and veterinary led training courses.

**Section 9: Documents :** Standards aim to ensure that there are plans and procedures in place to ensure safe and legal food production. Those documents must be displayed in a position available to those involved in farm tasks and anyone who may attend in an emergency situation.

**Section 10: Milk Production:** Detailed parlour plant cleaning protocol available and on display, including stages of wash and final rinse, products used, water temperature and checks undertaken (frequency). If auto wash used Parlour plant cleaning protocol 12 stages should be detailed along with frequency of checks undertaken.

**Section 11: Antibiotic Failures:** Each antibiotic failure must be reported to the prescribing vet.

**Section 12: Staff:** Assessments of skills and competency undertaken and documented.
