JUDGING CRITERIA 31ST DECEMBER, 2017

A1 List

For persons who have previously been approved by The Kennel Club to award C.C.'s in the breed and have completed their first appointment. To have the support of The Lancashire Heeler Club.

A2 List

For persons who fulfil all the requirements for the A2 List and who have been assessed in accordance with The Kennel Club requirements and accepted by The Kennel Club for inclusion on the A2 List and have the support of The Lancashire Heeler Club.

A3 List Breed Specialist

1. To have been involved with or owned a Lancashire Heeler for a minimum of seven years, and have the support of The Lancashire Heeler Club.
2. To have judged at least five Limit, Open or Championship Shows without C.C.'s with a minimum total of 25 classes and 80 dogs actually present and judged over a minimum period of seven years, with an acceptable geographical spread.
3. To have judged a Lancashire Heeler Club Show.
4. To have attended a seminar given by a K.C. Accredited Trainer and passed the relevant examination on K.C. Regulations and Judging Procedures.
5. To have attended a seminar given by a K.C. Accredited Trainer on Conformation and Movement.
6. To have attended a Conformation and Movement "Hands On" Assessment conducted by a K.C. Accredited Trainer and passed the assessment.
7. To have attended at least one Breed Specific Judging Seminar run in accordance with the K.C. Code of Best Practice and passed an examination and/or assessment where applicable.
8. To have bred or owned a Lancashire Heeler or a minimum of three dogs when they have obtained their first entry in the K.C. Stud Book (save in exceptional circumstances).
9. To have stewarded at twelve shows.

A3 List Non Breed Specialist

1. To have a minimum of seven years judging experience in any breed (including five years in this breed) and have the support of The Lancashire Heeler Club.
2. To award C.C.'s in at least one other breed.
3. To have judged the breed at least five times at Limit, Open or Championship Shows without C.C.'s with a minimum total of 40 classes and 80 dogs actually present and judged.
4. To have attended at least one breed specific judging seminar run in accordance with the relevant K.C. Code of Best Practice and passed an examination and/or assessment where applicable.
5. To have bred and/or owned a minimum of three dogs of any breed when they obtained their first entry in the K.C. Stud Book (save in exceptional circumstances).

B List Breed Specialist

1. To have been involved with or owned a Lancashire Heeler for a minimum of five years and have the support of The Lancashire Heeler Club.
2. To have judged the breed at least three times at Limit, Open or Championship Shows without C.C.'s, with a minimum total of 12 classes and 30 dogs actually present and judged.
3. To have attended at least one Lancashire Heeler Club Breed Specific Judging Seminar

B List Non Breed Specialist

1. To have a minimum five years judging experience and have the support of The Lancashire Heeler Club.
2. To have judged the breed at least three times at Limit, Open or Championship Shows without C.C.'s with a minimum of 12 classes and 30 dogs actually present and judged.
3. To have attended at least one Lancashire Heeler Club Breed Specific Judging Seminar

C List Breed Specialist

1. To have been involved with or owned a Lancashire Heeler.
2. To have attended a Lancashire Heeler Club Breed Specific Judging Seminar

C List Non Breed Specialist

1. To have displayed a distinct interest in Lancashire Heelers when they have been exhibited.
2. To have attended a Lancashire Heeler Club Breed Specific Judging Seminar
