


A Flame Trust Appeal for Playground Equipment in Northern Romania

In October 2019, Calin Rezmuves and Dave Pope from Flame Trust visited a home in SIGHET, Maramures in Northern Romania – a home for children and young adults with severe learning difficulties.

Having worked successfully the previous year with the official Social Services Department in the area, for the provision of appropriate bedding and furniture in another home in the vicinity, Flame has been invited to assist with the supply of suitable recreational equipment for the home in SIGHET, together with the re-generation of the outdoor space for therapy and exercise.

The request for assistance is particularly poignant in that this is the area where Calin spent the first nineteen years of his life in an orphanage.

“I want to give something back to improve the life chances of those who are in care”, he said. “My experience has left me with a sense of responsibility for those who are in a challenging environment, where I can help and improve their lives”.

It is envisaged that work on the ‘Playground Project’ will commence in late Spring 2020, with completion in the summer of the same year. Considerable research and planning will ensue, making sure that the playground is appropriately equipped with facilities, specifically adapted to meet the needs of children and young adults – including swings, rest areas and recreational equipment in a sympathetic and safe environment.

The cost of this work is likely to be approximately £12,000, but this will be closely monitored and managed by Flame Trust, to maximise the potential of all gifts, grants and donations.
