

## STANDARDISED PRICE LIST

All funeral directors are legally required to publish this Price List for a standardised set of products and services. This is to help you think through your options and make choices, and to let you compare prices between different funeral directors (because prices can vary).

<b>ATTENDED FUNERAL (funeral director's charges only)</b>	<b>£3060.00</b>
This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.	
Taking care of all necessary legal and administrative arrangements	£899.00
Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care	£295.00
Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at the funeral director's branch premises	£595.00
Providing a suitable coffin – this will be made from wood veneer	£625.00
Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer)	£ 1.00
At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle	£645.00

<b>UNATTENDED FUNERAL</b>	
This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.	
<b>Burial (funeral director's charges only)</b>	<b>£990.00</b>
<b>Cremation (funeral director's charges plus the cremation fee)<sup>2</sup></b>	<b>£1713.00</b>

<b>FEES YOU MUST PAY</b>	
For an Attended or Unattended burial funeral, the <b>burial fee</b> . <sup>1</sup>	<b>£650-£900</b>
In this local area, the typical cost of the burial fee for local residents is:	<b>£650-£900</b>
For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees.	
For an Attended cremation funeral, the <b>cremation fee</b> . <sup>2</sup>	<b>£810-£980</b>
In this local area, the typical cost of a cremation for local residents is:	<b>£810.00</b>

<sup>1</sup> This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave, or for reopening and closing an existing grave.

<sup>2</sup> In England, Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.

**DISBURSEMENTS (THIRD PARTY) ADDITIONAL COSTS**

In addition to the cost of our services, there are additional fees charged by the relevant Crematorium or Cemetery and for the completion of a Doctor’s Cremation Form (if applicable).

Other optional third party costs would include, for example: the Minister or Celebrant fee, Floral tributes, Newspaper Death Notices and Webcasting fees.

These prices vary as they are third party controlled costs.

## TERMS OF BUSINESS AND DISCLOSURE OF INTERESTS

### TERMS OF BUSINESS

- An estimate can be provided over the phone or in person. At any funeral arrangement an estimate will be provided, and a copy will be given to the funeral client.
- Deposits/Disbursements (All third-party fees) are to be paid before the funeral. All payments must be cleared at least 48 hours prior to the funeral service (this does not include a Direct or Simple funeral).
- For a Direct or Simple funeral, these are to be paid in full and funds must be cleared 48 hours before the funeral date and no discounts can be applied.
- The final balance must be paid by 30 days after the funeral (unless otherwise agreed by us in writing).
- Please let us know if you are using a third party to make a payment for the funeral, such as a solicitor administering estate, life insurance or if you have funeral plan with us.
- Payment Types - we accept payment by Bank Transfer, Credit or Debit card and Cheque (payment by cheque will mean funds must clear before the funeral service).
- Non-Payment - if there are any problems paying the final invoice, we will look to help make an arrangement to pay, depending on your circumstances. If the balance is not paid in the agreed time frame this will be passed onto the collections team and any non-payments can lead to a CCJ and interest added to the funeral account.
- You have a cooling off period of 14 days. If you wish to cancel any services within this time you must do so in writing within 2 business days. Any chargeable services incurred by Rea Funeral Services, commenced in this time, you will be liable to pay.

### **SIMPLE FUNERAL (ATTENDED).....£2250.00 plus disbursements\***

#### **Our services include:**

- Provision of a simple wood veneered coffin, lined and fitted with a nameplate.
- Removal of deceased from a local address to funeral home during office hours (9am-5pm)
- Care of deceased
- Viewing of deceased during office hours (9am-5pm Mon-Fri)
- Provision of hearse from funeral premises direct to crematorium
- Providing a funeral director to conduct funeral service

**\*Additional Disbursements Costs** i.e. Crematorium fees, Doctor's fees (£82) and Celebrant fees are additional. Please see above for pricing regarding these costs.

### **DIRECT CREMATION (NON-ATTENDED) .....£1795.00 Inclusive**

**This type of funeral is a direct cremation, which means there is no funeral service or mourners attending at the crematorium.**

- Completion and delivery of all documentation to relevant authorities
- Provision of a basic coffin
- Removal of deceased from hospital (within 25 mile radius) direct to crematorium at a time of our choosing

- Crematorium fee (Cremation date, time and location allocated by Funeral Director)
- Doctor's fee for completing cremation certificate (if applicable)
