Terms and Conditions:

The hiring contract is between the Hirer and the Owner of Cae Bach Caravan.

Weekly bookings: The booking form is to be accompanied by a deposit of 20% of the total rent. The balance of the rent must be paid 6 weeks before the commencement of the holiday. Bookings may be subject to cancellation by the owners if the payment balance is not received by the due date.

Payment in full is required for bookings made less than 6 weeks prior to the start of the holiday or cash on arrival if booking is made at short notice.

Weekend bookings: the full rent is due with the booking. This is non-refundable in case of non-arrival / cancellation.

The Hirer agrees to take all reasonable and proper care of the property including furniture, fixtures and fittings and to leave the caravan in a clean and tidy condition at the end of the holiday. The hirer agrees to pay for any breakages, losses or damage to the property before departure. The Owner or their representative shall be allowed access to the accommodation at any reasonable time during the holiday.

The number of persons using the accommodation at any time must not exceed the number stated.

Cancellation:

If the Hirer wishes to cancel the booking prior to the six week period before occupation for non-insurable reasons he/she should advise the Owner immediately by telephone, followed by a confirmatory letter. Upon receipt of such letter the Owner will (but without any obligation to the Hirer) use their best endeavours to obtain a replacement letting and, if such replacement is obtained, will then refund the Hirer any monies paid (excluding deposit).

If the caravan is unable to be re-let the Owner shall be entitled to retain all payments already made and to recover, if not already paid, the balance of the hiring charge.

Cancellation / Travel Insurance Cover

Insures will reimburse your irrecoverable travel or accommodation charges if you or a member of your party is unable to take your holiday as arranged due to any cause beyond your control, occurring after payments of the premium.

We suggest that you contact your usual Insurance Agent and take out an appropriate policy. It remains the Hirer's responsibility to arrange their insurance cover.

If, for any reason beyond the Owner's control, the property is not available on the date booked, all rent paid in advance will be refunded in full (including the deposit). The Hirer shall have no further claims on the Owner.

Arrival and departure times: The caravan will be available after 3pm on the day of arrival and must be vacated by 10am on the day of departure unless other arrangements have been made with the owner.

As this is a working farm, with hens, lambs and other livestock nearby, please keep dogs under control at all times. Thank you.
