Restoring the Alne Verges – update 10-Dec-2018

David Willis and I had a constructive meeting with Highways (NYCC Highways Manager Jayne Charlton and NYCC Councillor Peter Sowray) this morning.

They were keen that we paid the total of the outstanding invoice, £54,011 + the vat element of £10,802.20. They apologised for telling us originally (and erroneously) that we didn't have to pay VAT. But we can claim the VAT back which they can't.

From their side, they were keen to finish the works including the footways and driveways as laid out in the agreed table dated 13-Jul-2018. They had a plan which would complete this in the summer of 2019.

The proposed way forward is as follows:

- 1. Alne Parish Council claim the £10,802.20 VAT back on the invoice that we have already received.
- 2. Highways and Alne Parish Council agree in writing on the following schedule of works to take place in the summer of 2019:
 - (a) All the footways will be repaired and resurfaced the full length of Main Street from the Village Hall to include Drinsey Nook on the north side and Pond Farm on the south side.
 - (b) Along this same length, all the existing made-up driveways to be resurfaced, from the back edge of the new setts (or existing limits where setts do not exist) to the resurfaced footways.
 - (c) The six driveways that are not currently fully made up or are seriously dilapidated will be made up and resurfaced from the back edge of the new setts to the resurfaced footways.
 - (d) The dropped kerbs in Mitchell Lane will be installed.
 - (e) The row of setts outside Ouseburn House will be repaired once the new owners are in situ.
 - (f) The pavement down Church Wind will be repaired and resurfaced.
 - (g) Any associated drainage or contingency works will be for NYCC to do.
- 3. Following receipt of:
 - (a) a formal confirmation from NYCC that all the above works will be carried out;
 - (b) the confirmed Programme Date for these works from Highways in the New Year; Alne Parish Council will pay the outstanding invoice for £54,011 + VAT in full.
- 4. Alne Parish Council will make a further contribution of £3,247.80 + VAT for the work under 2(c) above and Alne Parish Council will take responsibility for obtaining the relevant contributions from the relevant owners. This amount will be held in retention, and not be payable to NYCC until all the works in section (2) above are complete.
- 5. NYCC Highways confirmed it was their intention to surface-dress the length of Main Street road carriageway during the summer of 2019.

The works will not be affected by any budget cuts or changes in councillors, with Councillor Sowray committing personally to oversee the timely completion of all the agreed works. |
