21/13 ELECTION OF CHAIRMAN

Cllr Brech was unanimously elected as Chairman.

21/14 ELECTION OF VICE-CHAIRMAN

Cllr Walker was unanimously elected as Vice-Chairman.

21/15 APOLOGIES & DECLARATION OF INTERESTS

Apologies were received from District Cllrs Taylor and Thompson.

21/16 MINUTES OF THE MEETING HELD ON 9 FEBRUARY 2021

Minutes previously circulated and these were accepted.

21/17 CLERK'S REPORT AND MATTERS ARISING FROM THE MINUTES

- a. Cllr Walker would progress the emergency plan after lockdown ends. The closure of RAF Linton-on-Ouse would change the focus of the plan.
- b. No street lighting issues remained at the present time.
- c. The consultation should have now finished on the yellow lining. The Clerk would ask NYCC when the work will be undertaken.
- d. Nothing more had been heard from the Land Registry regarding Sand Bed Dyke. The Clerk would chase this up.
- e. Yorkshire Water had still not agreed to an onsite meeting. The Clerk would continue securing a date. Several setts removed by Yorkshire Water were still to be replaced together with some which were the responsibility of NYCC Highways.
- f. All the trees on Main Street that required replacing had been dealt with.
- g. A resident from Alne Station had arranged with Hambleton DC to install litter bins on the A19 towards Thirsk. It was agreed not to take up the offer of verge side anti-littering signs from Hambleton DC due to their ineffectiveness.
- h. The Clerk would seek out alternative depth gauges for the Kyle. A landowner had agreed to the installation if it did not interfere with the river.
- i. The flooding on the playing field had been resolved by the unblocking of a local farmer's drains
- j. The powers to hold remote meetings would end on 7 May. A High Court challenge had been unsuccessful.
- k. NYCC had confirmed that a bid for funding for a new bridge had been made for this financial year. It was the number one priority footbridge in the Hambleton area. A temporary replacement was not feasible as it would cost nearly as much as the new one.

- m. Cllr Edwards had liaised with the Outwood Grange Academy. All the staff including the Head Teacher had remained in post and were working to address the Ofsted concerns.
- n. No update had been received regarding the planning enforcement at the Church House development and the Clerk would chase this up.

21/18 ALNE COMMUNITY PLAN

Cllr Walker reported that the community plan was created in 2009. Refreshing it will depend on willing volunteers. It was agreed that an article would be put in the parish newsletter and on the website asking for volunteers and that Cllr Walker would coordinate this. The scope of the plan would include footpaths and affordable housing.

21/19 BUS SHELTERS

It was agreed that the provision of bus shelters was not suitable for the village due to the flexibility shown on pick up and drop off at the moment which would be impacted by formalising arrangements. The aesthetics of a bus shelter would also not fit with the village.

21/20 SOCIAL MEDIA

It was agreed that the Council did not wish to have a presence on Social Media due to it being unregulated and open to cyber bullying and incorrect information. The official communications of the Council would be done via the noticeboards and website as required by legislation. Anyone is free to access this information and raise any concerns directly with the Councillors or the Clerk.

21/21 STREET FAYRE

It was agreed that the normal application be made for street closures for the fayre to take place on 5 September this year.

- c. The Chairman reported that he had conducted a speed gun session on Monk Green in response to concerns that cars were speeding on their way from the school. It was found that out of 37 vehicles none exceeded 28mph with 25% between 26 and 28mph, 50% between 21 and 25 mph with the remainder 20mph and below. Further surveys would be taken before the next meeting and Cllr Walker volunteered to take part. This would provide evidence as to whether a matrix speed sign was required.
