

# NOTICE OF ORDER

## HIGHWAYS ACT 1980 SECTION 26 & 118 WILDLIFE & COUNTRYSIDE ACT 1981 SECTION 53

Footpaths CP-514 (Part), in the Parish of Cleeve Prior  
Public Path Creation and Definitive Map Modification Order 2013  
&  
Footpaths CP-514 (Part), in the Parish of Cleeve Prior  
Public Path Extinguishment & Definitive Map Modification order 2013

Notice is hereby given that the above referenced Orders have been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Orders.

The **start date** for the above Orders is **19 November 2015**.

Consideration of the Orders will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Orders, if confirmed without modifications, will be to modify the definitive map and statement for the area by (i) creating a public footpath and (ii) extinguishing a public footpath as follows:

(i) Creating the length of footpath CP-514 (part) which has a width of 2 metres and commences at Ordnance Survey grid reference (OSGR) SP 0830 5017. The path proceeds in a generally south south westerly direction, along a track up a slope through woodland for approximately 105 metres. The footpath then turns to head in a generally south south easterly direction, for approximately 20 metres, to terminate at OSGR SP 0828 5005.

(ii) Extinguishing part of the length and the entire width of footpath CP-514 (part), in the Parish of Cleeve Prior, commencing at Ordnance Survey grid reference (OSGR) SP 0830 5017. The path proceeds through woodland in a generally south westerly direction, for approximately 110 metres, to cross a boundary and continues through woodland in a generally south westerly direction, for approximately 195 metres. The footpath then crosses access land, for approximately 55 metres, to terminate at OSGR SP 0804 4993

### **Timetable for sending in statements of case and comments**

#### **Within 2 weeks of the start date [by 03 December 2015]**

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Orders.

#### **Within 8 weeks of the start date [by 14 January 2016]**

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Orders.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a copy (excluding copies of any supporting documents, although these will be available to view at the Authority's offices) to the Authority, everyone who has made an objection or representation and any other person who has written to us in respect of the Orders.

#### **Within 14 weeks of the start date [by 25 February 2016]**

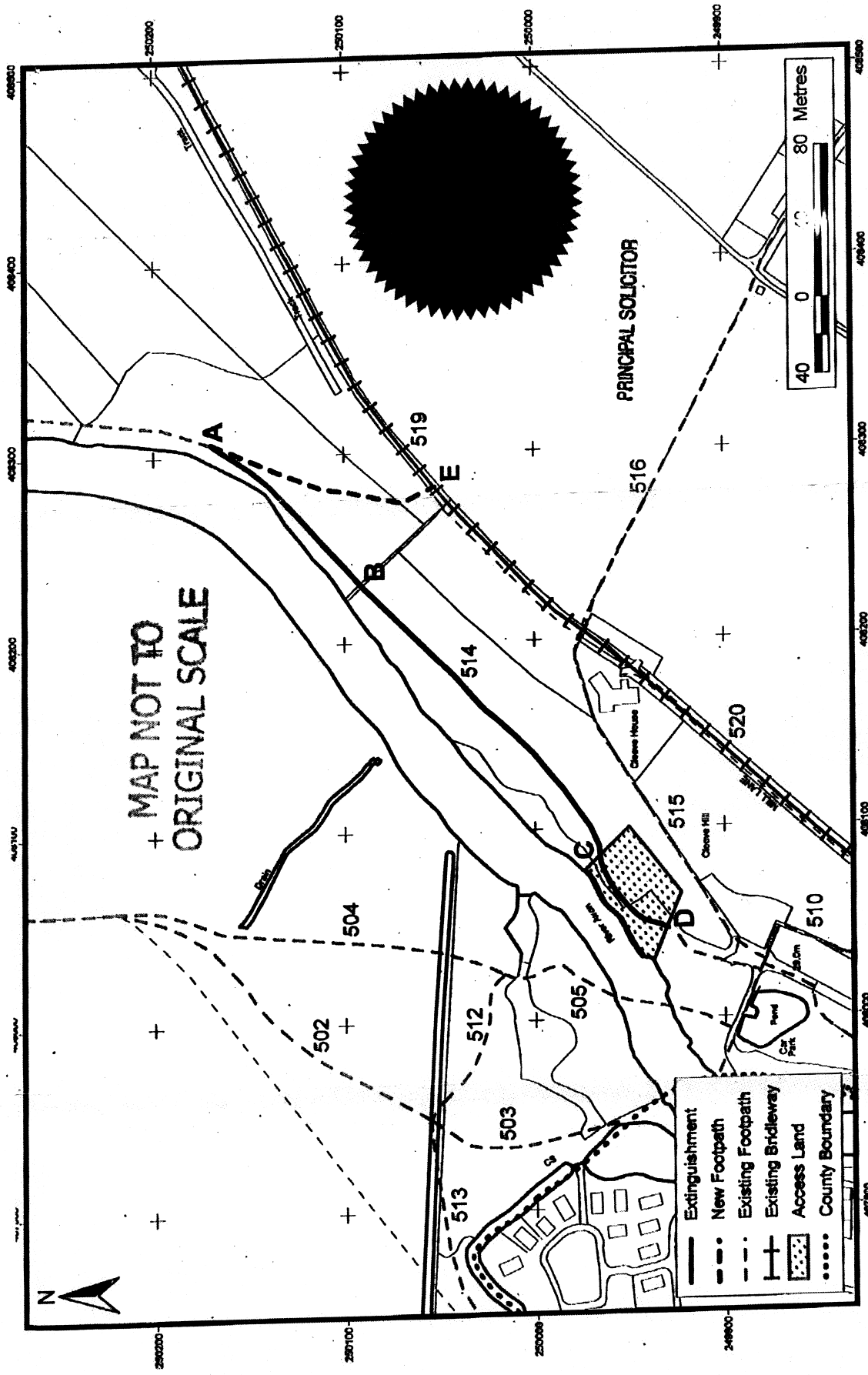
Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Orders must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Orders must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time.

All parties must keep to the timetable set out above and ensure that statements of case are received by the Secretary of State on time. Late documents will be returned.
