Course Bookings

Courses must be booked in advance. If the booking is not able to be fulfilled, Butterfly Hypnobirthing will promptly refund all monies.

Contract

Butterfly Hypnotherapy courses follow 'The KG Method' of hypnobirthing. Once the booking is processed, this constitutes a contract between Hannah Steventon of Butterfly Hypnobirthing and the participant. The contract is not between KG Hypnobirthing and the participant.

VAT

Participant cancellation

The fee will be repaid promptly and in full if your baby arrives before the course or in the very unlikely event of the course being cancelled. These are the only circumstances under which a refund will be made.

Course cancellation
