3. Comments for Local Transport Plan (LTP4)

Sutton Lane, Sutton-in-Craven

Sutton Lane is a narrow road used by buses, ordinary pedestrians, and employees walking and cycling to Airedale Hospital.

Due to the ever increasing development the road is getting busier and busier with many more drivers using the road to avoid the congestion on Cross Hills Main Street and Station Road. The further increase in traffic is putting pedestrians at further risk on which is already a treacherous road to walk on.

Please can you seriously consider the need for a footpath to ensure the future safety of all?

Ellers Road

A steep winding road again used as a rat run to avoid congestion. The road is a narrow and tortuous entry road to the village at the bottom of a steep hill Approximately 1.5 miles long.

Although there are some existing warning and speed limit signs large wagons still try to use the road and cars are still speeding.

The road would benefit from more upgraded signage and carriageway markings.

Crosshills Traffic

Crosshills and Glusburn and Sutton-in-Craven cannot cope with the ever increasing volume of traffic. Included in the draft Local Plan 2, a scheme was put in place to provide a link road over the railway line.

This should be re-instated it would remove the highway problems on Kildwick roundabout where traffic builds up from the closure of the level crossing creating queues of standing traffic on all the other feeder roads. The level crossing is closed 45 minutes in every hour.

Crosshills Main Street and Station Road as stated above traffic is congested continuously. It is extremely difficult for motorists to pull out at the top of Holme Lane. Traffic Lights here and the A6068 would help resolve problems.

To help ease the ever worsening traffic congestion in Sutton, Crosshills and Glusburn it is important not only to maintain existing public transport links but to move ahead with plans to re-open the railway station at Crosshills.

4. Park / Pavilion Report

Burst Pipe

A plumber was called out early this morning to a burst pipe in the potting shed. The pipe runs from Main Street and splits into two, one leading to the potting shed and one to the lodge. The pipe is made of lead. As a precaution Yorkshire Water are checking the pipes and testing the water to the lodge.

Playground Inspection Training

YLCA in conjunction with RoSPA Play Safety Ltd are offering a bespoke half day playground inspection training for volunteers at a venue in South Yorkshire; which provides attendees with the knowledge required to carry out routine visual daily/weekly inspections of play areas.

Vandalism

It has been noted that due to the lack of a regular police presence incidents of vandalism, anti-social behaviour and petty crime are increasing in the village. The Park, bus shelter by the Village Hall and Cricket Field are to name but a few.

It was resolved that the clerk write a letter to the North Yorkshire Police informing of this.

It was **resolved** that a letter be sent to Julian Smith MP to emphasise the need for North Yorkshire Police to retain their current level of funding in the face of impending cuts due to proposals for Devolution.

5. Flood/Sewerage Report

Cllr. Hart reported that from Glusburn Bridge to Holme bridge the beck sides have become very overgrown and need clearing to allow the beck to flow freely.

It was resolved to inform the Environment Agency and request a site visit.

Cllr. Morrell informed of his discussions with Claire Brown from the Environment Agency and is awaiting confirmation of a date for a site visit.

It was resolved that the clerk contact Claire and arrange a confirmed date.
