North Yorkshire County Council Report from Councillor Philip Barrett

Public Rights of Way

Due to cuts the Public Rights of Way on the becksides, Holme Lane and from Hazel Grove down to the bridge will only be cut once a year, at the end of July.

Prohibition of Waiting and Loading and Provision of Parking on Main Street

Following consultation The Traffic Regulation Order for a length of lines (approximately four car lengths) to prohibit parking across the front of the main Church gate received no objections (see clerks report).

Crosshills Library

Following consultation and due to budget cuts North Yorkshire County Council decision is that Crosshills Library will become a Community run Library with 12-15 hours of Professional Support. This is a difficult time for all including the current staff who are excellent and have worked hard for the community in providing an excellent service.

Local Transport Plan (LTP4)

The County Council is the local transport authority for North Yorkshire (excluding the city of York). It is responsible for local transport and for the management, maintenance and improvement of the highway network (excluding motorways and trunk roads). The authority are currently working on a new local transport plan which will set out the Council's plans and strategies for the local transport for the next 30 years.

Cllr. Barrett advised the Parish Council to put forward the councils priorities and views.

 - Letter to Bradford Metropolitan Council enquiring if any progress has been made with the proposed traffic regulation order for yellow lines on the Junction of Sutton Lane End turning right on to the B6265.

1. Prohibition of Waiting and Loading and Provision of Parking on Main Street

Notice of the Order appeared in the paper on the 18th June 2015. The Notices applies to Main Street Sutton. 17.5 m east from the extended east wall lines of Gatering Lane. East for a distance of 21.8m.

Double Parking on Main Street particularly near the park and church is a major problem causing congestion. Buses are having difficulty getting through as well as cars.

Following a meeting with Highways to look at a solution. It was proposed that an order be made for a length of lines (approximately four car lengths) to prohibit parking across the front of the main Church gate. The restriction is proposed to maintain the free flow of traffic (to leave a space so cars can pull into pass without having to reverse a considerable length). The Traffic Regulation Order will have an exemption for wedding and funeral related vehicles.

2. Police Matters

a) Bus Shelter – Outside the Village Hall

Once again another pane of glass was smashed on the shelter. The Police were give some leads which they have followed up.

Crimes of Note dealt with in June – Sutton-in-Craven, Crosshills & Glusburn

3rd June 2 overnight dwelling burglaries 2 vehicles taken with keys, Sutton-in-Craven

4th June 13 Koi Carp Stolen from garden pond, Sutton-in-Craven

- 4th June Garage workshop entered and chainsaw and power tools taken, Sutton-in-Craven
- 4th June Petrol lawn Mower stolen from garden in Glusburn
- 6th June 44 sheets Insulation stolen from Building site Station Road, Crosshills
- 11th June Guinea Pig Stolen from hutch others left behind Crosshills
- 16th June Burglars disturbed in night attempting entry Police search no gain, Sutton-in-Craven

You may suspect some of these crimes are linked as they are similar crimes on the same dates, and this is a clear indication criminals are travelling extensively within Craven to commit these offences. There have also been a number of dwelling houses attacked this month, as well as commercial properties. So many of our crimes are to insecure premises or have happened when property has been left unattended.

3. Defibrillator for the Park/Village

It was **resolved** to acquire the forms for a grant from Craven District Council.

4. Park / Pavilion Report

Sponsorship

The opportunity for members of the local community to sponsor of gardens, benches and picnic tables continues in the park. So far this year four gardens are being sponsored along with a recycled bench seat and a picnic table.

Fundraising Event - Request

Sutton Football Club would like to hold a fundraising event in the park on Sunday 2nd August 2015. The event would be a smaller version of Funday.

The event is to consist of a series of football matches on the 2 small pitches (main field) all allowing each of their mini teams to invite an opponent for a friendly game. On the fundraising side BBQ, Tombola, Bun Stall, Bouncy Castle and other traditional fundraising ideas. Also they would like to hold a Balloon release (as they did for the Centenary event in 2012).

The club hold all relevant Public Liability Insurance and would provide full risk assessments for the event and ensure all correct safety procedures are followed and manage the arrival and departure of teams and their parking to ensure minimum disruption to the village.

It was **resolved** that the request be granted.

Football Club – Storage

Sutton Football Club has expanded in recent years and currently has approximately 250 members. It regularly uses the park for training on evenings during the week and matches on weekends.

The club has put forward a request for increased storage facilities for their equipment. They currently store some of their equipment in the old bowling pavilion in the park along with the park staff and playgroup. Storage space is limited. The club currently stores further equipment in a garage but the club are losing access to this.

The football clubs proposal is to put doors on the stone shelter in the park. The stone shelter was originally built for mobility scooters to shelter in wet weather. It has been advised it is no longer used for that purpose and currently a bench is situated in the shelter.

The Club will fund all the cost for the alterations.

Plans circulated to members.

It was **resolved** that the request be granted subject to advance notice of start of works and a rental charge of £5 per year.

Funday

Thank you to the Village Committee Chair, members and its team of volunteers for making the event possible. The dedication and commitment to making this event run smoothly and the hours of ensuring the gala was a success.

Sluice Gate

The cogs are worn and making the sluice gate difficult to open.

It was resolved that the sluice gate be assessed and parts replaced as needed. Cllr. Green suggested Mr Clough may be of help with regard to cogs.

5. Flood/Sewerage Report

Information from Yorkshire Water

As you are aware - there are capacity issues on the sewerage system that serves the area and these may restrict the options available to a developer at the planning stage. There are however guidelines that should be followed and can be enforced via the environment agency where connection to the public sewer is restricted and options such as package treatment plants are to be used

The Environment Agency would investigate any pollution that was reported to them and take action against the body responsible - be that Yorkshire Water if the problem was from a public sewer or a private developer if the problem was coming from a private un-adopted system such as a package treatment plant.

6. Footpath Report

a) Fallen Tree – Lyndhurst Wood

A fallen tree was reported on the footpath leading from Lyndhurst Wood to Hazel Grove. The matter has been reported to Public Rights of Way and the owner of the land. The tree has now been removed from the path.

7. Standards Committee - Parish Representatives

Three parish representative vacancies.

The District Council's Standards Committee has, under the Localism Act 2011 responsibility for dealing with standards complaints against elected and co-opted members of Parish Councils. The Standards Committee is comprised of five District Councillors each with voting rights, together with up to four co-opted Parish Councillors (non-voting). The Committee is also supported by three Independent Persons appointed by the Council who offer guidance and advice to the Monitoring officer in dealing with standards complaints.

8. North Yorkshire County Council's Craven Area Committee – Vacancies for Parish Council representatives

The Craven Area Committee currently has two vacancies for representatives from Parish Councils to serve on the Committee until 2017 as co-opted Members and, therefore, is seeking nominations from local Parish Councils to fill those vacancies.

9. Local Transport Plan (LTP4) Consultation

The County Council is the local transport authority for North Yorkshire (excluding the City of York). It is responsible for local transport and for the management, maintenance and improvement of the highway network (excluding motorways and trunk roads). The highway network consists of approximately 9,200km of road, 4,000km of footway, 47,000 streetlights and 2,000 bridges. The authority are currently working on a new local transport plan which will set out the Council's plans and strategies for the local transport system for the next 30 years. The information from this consultation will help inform the long term priorities that will be given to different aspects of local transport. It was **resolved** a letter be forwarded to the County Council

In terms of the presumption in favour of sustainable development it is considered that the adverse impact in relation to the individual character and identity of the settlements, their overall character and appearance and that of the area generally would significantly and demonstrably outweigh the benefits when assessed against the policies in the NPPF taken as a whole.
