Minutes: The Minutes of the 2019 AGM held on 23rd May were circulated and had previously been accepted as a true and correct record.

Chairman's Report: Since the last AGM has been an eventful time. The hall has been used small scale to comply with Coronavirus restrictions, especially Social Distancing. Due to this Income has been restricted, but the costs continue. However, as a result of Government Grants via the council, the hall has remained solvent thanks to Barrie & others who have applied for these. The Clothes recycling bin arrived to support AE Donate. Thanks to everyone who has helped over the past couple of years, perhaps some semblance of normality will begin to appear in the coming year.

Treasurers Report: Barrie issued the Parish Hall accounts which showed a surplus for 2020 of £1,010 and for 2021 of £3897 for the year.
Current account balance: £10,184 (2020 £6,287)

Secretary's Report: It has certainly been an unusual year. There has been very little formal activity surrounding the hall, with it being either closed or under limited use for much of the time. Therefore, we have had only 1 meeting since the first lockdown in March 2020. There have still been maintenance issues to sort out and there has been the addition of the canopy over the front door. As always SallyAnne has borne the brunt of and issues, being first point of call at the hall, but thank you to all who have supported efforts to keep the hall in in shape over the past year. Now, hopefully the worst is behind us & we can look forward to getting back to some sort of normality.

Booking Secretary's Report: SallyAnne reported (as Geoff was not present) that regular bookings are starting to return, along with some new regulars. A few private bookings are also starting to be requested.
