The product has to be labeled due to the calculation procedure of the “General Classification guideline for preparations of the EU” in the latest valid version.

#### • Classification system:

The classification is according to the latest editions of the EU-lists, and extended by company and literature data.

## Section 4 - First Aid Measures

- **After inhalation:** Supply fresh air; consult doctor in case of complaints

- **Suitable extinguishing agents:**

CO<sub>2</sub>, powder or water spray. Fight larger fires with water spray or alcohol resistant foam.

Can form explosive gas-air mixtures.

- **Protective equipment:** Wear self-contained respiratory protective device.

- **Additional information:**

Collect contaminated fire fighting water separately. It must not enter the sewage system. Dispose of fire debris and contaminated fire fighting water in accordance with official regulations.

- **Person-related safety precautions:**

Wear protective equipment. Keep unprotected persons away.

Keep away from ignition sources.
