The Club was formed to keep past and present employees of the RHS in touch with each other.

All staff, trainees and volunteers are eligible and welcome to join as members.

A Club Journal is published annually, giving news of members and changes of address; also articles contributed by members.

Gardens Club Day is held annually at Wisley, when members can get together to visit the Garden and attend the Annual General Meeting. A Summer Evening event is also organised each year at Wisley.

The Club membership card admits two to the Gardens at Wisley, Rosemoor, Hyde Hall and Harlow Carr on any day when they are open.

The annual subscription is £5, and is payable on January 1st each year (please make cheques out to "RHS Gardens Club") or, an easier method of payment is by Standing Order.

Life Membership costs £75.

RULES

1. The name of the Association shall be the RHS Gardens Club.
2. The object of the Club shall be to keep past and present employees, trainees and volunteers of the RHS in touch with each other and thus promote a sympathetic, friendly and mutually helpful association.
3. All past and present, employees, trainees and volunteers of the RHS shall be eligible for membership.
4. The Officers of the Club shall consist of a President, Vice-President, Treasurer, Editor, Secretary and an Executive Committee of seven. All Vice-Presidents and Past Presidents are ex-officio Members of the Committee.
5. The President shall be elected for a period of 2 years. All other Officers and Members of the Committee shall retire annually but be eligible for re-election.
6. The election of Officers shall take place at the Annual General Meeting.
7. The Annual General Meeting shall be held at Wisley in September every year.
8. A Club Journal shall be published annually and shall include, subject to Members' agreement, a full list of Members' addresses every third year and a supplementary list in the years between.
9. The annual subscription shall be £5, payable on the 1st January each year. Any Member whose subscription is two years in arrears shall be notified and shall cease to receive the Club Journal until the arrears are fully paid up. Those Members who wish to commute their annual subscription and become Life Members shall be able to do so for £75.
10. These rules shall be subject to additions or alterations only at the Annual General Meeting or at a Special General Meeting called for the purpose. Notice of the proposed alteration or amendment must be sent to the Secretary not less than six weeks before the date of such meeting and the requisition for such a Special Meeting must be signed by not less than 18 members.
