2] Declarations of Interest There were none.

3] Minutes from previous meeting held on March 3, 2009, were accepted as circulated and signed by the chairman after it was pointed out there was no evidence to suggest the six youngsters seen by the police in regard to a disturbance at an event at the village hall had caused any damage and the reference to Gables End in the planning discussions should have said the gable at Wess's Barn on Widmerpool Road.

5] Correspondence

Rushcliffe Borough Council advised of details for the booking of the village hall for the European and County Council Elections on Thursday June 4. The Borough Council confirmed the availability of the necessary equipment for the litter pick day on June 6. Couns. Mrs Mary Elston and Mrs Charlotte James said they would attend the Rural Community Action Nottinghamshire Parish Council Forum event on community safety on June 11 at West Bridgford.

Rural Community Action Nottinghamshire advised of the necessity to impose the introduction of membership fees and the council agreed to accept this. The clerk said they had not operated a membership charge scheme for the past five years.

Nottinghamshire County Council gave details of a temporary restriction of Keyworth Road between its junction with Wysall Lane and Wysall Road for high friction surfacing. Nottinghamshire County Council confirmed it was unlikely a 'Welcome to Wysall' sign, would be erected in the near future on Bradmore Road because of lack of funding availability. The clerk was asked to enquire when the finger post directional sign to Wysall and Keyworth would be re-erected at the Bradmore Lane junction.

Rushcliffe Borough Council advised that the parish request for a scheme for an illustrated description board for Thorpe in the Glebe was being included in the Small Environmental Improvement Schemes Programme for 2009/2010 and beyond.

It was agreed to take up an offer from Rushcliffe Borough Council in regard to cricket coaching they were offering for Kwik Cricket for July 11 and for tickets for the Pro40 matches being played at Trent Bridge, to be used for a competition at the Strawberry Fair on June 20.
