- 3] MINUTES FROM PREVIOUS MEETING HELD ON APRIL 4, 2017 were accepted as circulated and signed by the chairman

The chairman brought forward the item on the agenda concerning the Casual Vacancy on the council. Mr Peter Wyles had indicated an interest in joining the council and was proposed and seconded and unanimously appointed. The chairman welcomed Coun. Wyles and thanked him for his interest. He signed the necessary Declaration of Acceptance form.

- 61 CLERK'S REPORT

Notts County Council had been in contact with Mr Webster at Disney House in regard to his highway concerns. The County Council District Manager Kendra Hourd, had advised they would not permit bollards or any form of barrier on the verge, whether publically or privately funded. She said the bollards near to the Village Hall were not the type designed to protect property and the ones that are designed to stop drivers dead, will do that literally and could kill the driver, which was why the Authority won't use such structures on the highway.

The officer said their focus was on reducing reported injury accidents and ensuring drivers were aware of bend hazards and that their vehicles don't leave the road in the first place. On that basis, they were happy to look at possible measures to highlight the presence of the bend to drivers, such as 'Slow' markings on the road surface or possibly bend warning signage on the Main Street approach to the bend in question. The clerk said the County officer had agreed this be added to their funding consideration list for a bend warning sign 'Slow' markings in a future programme.

Volunteer of the year award: The council agreed that it progress the award to be given to their late chairman David Roberts and to make this presentation at the Food Fair event. At the Christmas event it would present an award to former councillor Mike Stanley.

71 CORRESPONDENCE

Kendra Hourd, Notts County Council advised the council that a complaint had been received in regard to a lack of grass cutting on the edge of Main Street in Wysall between the Plough public house and the parish church. The clerk said he had passed on the email from the County to their contractor Peter James.

Coun. Birch expressed concerns in respect of information circulated in regard to badgers. The information had shown a badger being hugged by a lady. Coun. Birch pointed out that badgers could carry TB to humans and it was therefore unwise to suggest such close contact could be made with the animals. The clerk was to investigate the source of the information which involved Nottingham University.
