- 1] APOLOGIES Couns. Vicki Plant and Simon Stephens
- 2] MINUTES FROM PREVIOUS MEETING HELD ON JUNE 7, 2016 were accepted as circulated and signed by the chairman.
- 3] DECLARATIONS OF INTEREST There were none
- 4] PUBLIC PARTICIPATION, LIMITED TO 15 MINUTES
There were no members of the public present.
- 5] CLERK'S REPORT
The Council's Internal Auditor Mr David Dixon reminded the council that all invoices paid sheets presented to each meeting need to be signed by a member and all invoices paid must be initialled by the members signing the cheques.
Coun. Grenz has provided members with a copy of the Emergency Plan he has produced for the two villages. He was thanked for it. The council felt it should be entered on to the website.
- 6] CORRESPONDENCE
Vista360, website usage figures for June showing total hits in the month 1695 and total unique hits 849. Both figures showed an increase on each previous monthly figure since June 2015.

- 9] VILLAGE HALL AND PLAY AREA.
Coun. Sam Stephens had suggested the council look to buy three gazebos for hiring out to hall users if needed and to local residents. It was agreed they be purchased. It was agreed that the quick cricket equipment held in the hall should be donated to the scout group at East Leake.
Forthcoming events in the hall would include a wine tasting event on October 8, a food cooking event and the Christmas Fair in November.
