CLERK'S REPORT

Complaints to Rushcliffe Borough Council in regard to a nuisance from the Old Wood Yard site on Keyworth Road resulted in the contractors being given a notice to prohibit them having bonfires of rubbish on the site.

The clerk said that Data Protection arrangements were progressing.

7] CORRESPONDENCE

Time Assured had given a quote for repairs to church clock which was no longer chiming. A second quote had been sought from Cumbria Clock Company. They had made a visit to the church but no quote had yet been received.

Elston Parish Council wrote seeking support for their approach to DEFRA to complain about the use re use of A24 trap for rats and stoats, but which are also killing Hedgehogs. The council agreed to support Elston and the clerk was asked to write to DEFRA.

Notts CPRE annual meeting was to be held on Friday June 21 at the Hockerton Housing Project near Southwell. It would start at 5pm.

Rushcliffe Borough Council re Tour of Britain event. Wysall was on the route of the race and 120 cyclists expected and a large cavalcade of following cars. 11] VILLAGE HALL

Coun. Redfern reported the wine tasting event had made £250 for hall funds and the Treasure Hunt nearly £200. A silk painting workshop was planned for June 25.

The chairman said roof insulation work in the main hall was planned and it was expected the cost would be about £600. East Midlands Airport had given a £200 grant towards the cost of the work.

The new litter bins proposed were on order. There were no current plans to proceed yet with the new seats. The clerk was to progress the matter of a drainage problem on Keyworth Road. Members expressed concerns on dangers caused for motorists in the village where roads edges were disintegrating.

The chairman said he was to talk to Peter James in regard to trees at the village hall and in regard to a need to look at moss on parts of the play equipment at the rear of the hall.
