



She has attended safeguarding training, first aid training, has CRB check and UKCC Level 2 Coaching Qualification (all copy certificates provided in section1/section 2 of the CAPS folder).Safeguarding Officer has made all club members aware of the new EN online training programme, and this information is also available on the PSL Panthers website at http://www.pslpanthers.co.uk/safeguarding.html
4.3.5	Work in partnership with parents/carers and young people within the club	This is covered through the communication the club has with parents/carers. PSL Panthers communicates with parents/carers via post, email and phone.
