4 Minutes of the last meeting

5 Matters arising from minutes

5.1 Speeding in the village

Awaiting a response from the deputy police commissioner Andy Pratt. County Coun. Hartley to discuss with Coun. Charlie Edwards, the highways cabinet member for LCC this week.

5.2 Play area re-surfacing

The play area work is due to start in March. Coun. Newman to hold a health and safety site visit with the firm. He said the matting which is currently in the area will be taken up and piled up and anyone interested, can take. He will arrange with Pam Barton to publicise via social media. The new noticeboard has arrived and Coun. Newman will ask the play firm to put up when they do the works.

A hole in the pavement at the top of Old Laund Street/Wheatley Lane Road, had caused a flood into the play area. However this has now all been repaired by LCC.

Devanney gave details of the Pennine Lancashire Community Farm, who are always looking for projects. Suggested they attended a future meeting to discuss the edible credible project.

6 Reports from outside bodies

Coun. J, Hartley said she had spoken to Pendle Forest Sports Club about the jubilee celebrations and hopefully an event can be organised. The clerk has applied for lottery funding. Ideas to provide hanging baskets, planters etc for villagers to put red, white and blue plants in, was muted. Also, to place old wheel trims or similar painted in jubilee colours on the village lamp posts.

There is £840 left from the Barrowford and Western Parishes grant. The clerk to buy a bench and extra planters.

The precept was set at £12,500.

The grass cutting tender was discussed and it was agreed to award the village hall contract (£30 per cut) and the triangle area at the top end of Wheatley Lane Road (£70 per cut) to PDS Landscapes. This is on the basis of cuts from May to September.

It was agreed to re look at the pattern of grass cutting on the bypass, to avoid cross over cuts between LCC and the parish council contractor.

10 Any other business

Coun Devanney had reported a missing sign at Noggarth Road and damaged posts to LCC.

County Coun. Hartley had reported trees which had blown over near The Fence Gate and LCC had taken action.

Coun. Newman said light columns which had been installed outside Fence Gate Lodge and Church Cottage, have not been lit up. Also a blocked grate opposite Woodside Cottages. The clerk to report to LCC.

Coun. Myers said there are volunteer litter pickers cleaning the bypass, so no need for the lengthsman to also clear.

Coun Hall reported a hole in the entrance to the car park and also is to ask the school if the old play area noticeboard can be placed next to the Pendle Forest one by the school.

The clerk to report a pot hole at Croft Top.

The domain name for the website needs renewing. Coun Devanney to liaise with the administrator and obtain acess to the website to allow for a switch over to a new administrator via the clerk.
