MINUTES OF THE MEETING OF GIGGLESWICK PARISH COUNCIL HELD ON THE $12^{\rm th}$ April 2016

757. <u>Present</u>

Cllrs. Miss I.M. Perrings (Chairman), Mr. R.M. Jones (Vice-Chairman), Mrs. F.M. Airey, Mr. C. Coleman, Mr. G.J. Davidson, Mrs. J.M. Ewin-Newhouse, Mr. M. Pryal and with County/District Councillor Mr. R.C. Welch and the Clerk in attendance. Apologies for non-attendance were received from Cllr. Mrs. P.H.M. Simpson.

758. Declaration of interests

Cllr. Davidson declared a personal interest in Item 761.1, concerning a request from North Ribblesdale RUFC.

759. Minutes of the meeting held on the 8th March 2016

The minutes of the meeting, having been circulated in advance, were **APPROVED** as a correct record and **SIGNED** on the proposal of Cllr. Ewin-Newhouse seconded by Cllr. Davidson.

760. <u>Planning Applications:</u>

760.1 Received:

The Council had **no objections** to or comments on the following application: YDNPA: C/31/643A – replacement of garage, Four Winds, The Mains

760.2 Decisions:

The following decision has been **notified** by the relevant Planning Authority: CDC: 31/2016/16654 – proposed internal alterations to convert existing garage to dining area and utility room, to include replacing garage door with smaller window to match existing, 18 Lords Close, *granted*

760.3 Other Planning Matter:

CDC: New Local Plan final draft proposed developments. The Council decided to draft up a suitable response to adopt and forward to CDC at the next meeting.

761. To receive reports and reach decisions on various village matters.

- 761.1 Harrison Playing Fields: request from North Ribblesdale RUFC. The Council had received a request from North Ribblesdale RUFC to hire the Lower Fellings of the Harrison Playing Fields for some of its rugby training from the end of August 2016 until the end of April 2017. The Clerk was asked to seek confirmation from SUJFC that they do not require the use of the Lower Fellings for their football training.
- 761.2 <u>S.106 Lords Close.</u>

The Council had received confirmation that the updated planning gain agreement has been signed for Lords Close and that CDC will be monitoring the development for when it reaches the trigger point and then seek payment. In relation to this the Council had received a request to reconsider investing this fund into new play equipment and in its stead CDC would welcome a joint discussion to try and address the local youth/ teenage need for a skate park/pump track in conjunction with Settle Town Council. The Council decided to ask for more information.

761.3 Footway on Bankwell Road.

In relation to the drop between the tarmac and the gate entrance to the Lower Fellings of some 5 to 6 inches deep the Council agreed with NYCC Highway Authority's

preferred option to let the footway backfall from the kerb to the existing gate level. In addition to this the Clerk was asked to contact Wooler to tidy up along the new footpath.

761.4 Community resilience at parishes liaison meeting.

The contents page of NYCC's template emergency plan was circulated. The Clerk was asked to invite Mr. Wright, Senior Emergency Planning Officer, and/or Mr. Derry, lead officer in working with communities to develop and produce plans, from NYCC Emergency Planning Unit to the parish meeting in June or July.

- 761.5 <u>Update on exposed pipes in Tems Beck.</u> The Council had received a response from Electricity North West (ENW) and Northern Gas Networks (NGN) in relation to the two exposed pipes in Tems Beck. ENW had logged a job. NGN replied that the pipe has been exposed for some time and that there is no safety hazard because the pipe is not leaking. Mr. Butterfield assured the Council that the situation is 100% safe. NGN will take immediate action if this situation were to change.
- 761.6 <u>NYCC: changes at Household Waste Recycling Centres</u> The Council had received a letter from NYCC containing the new opening times at Household Waste Recycling Centres as: April to September from 8.30am to 5pm and October to March from 8.30am to 4pm and closed on Wednesdays. This letter was circulated.
- 761.7 Date and time for a meeting of the Trustees of Giggleswick Charities. The Council decided to hold a meeting of the Trustees of the Giggleswick Charities in June or July depending on the acceptance of invitation to a parish meeting described in item 761.4. The Council also decided to organise an evening event on behalf of the Trustees of the Giggleswick Charities on 10th September 2016.
