GOLF DAY at GOODWOOD - Monday, 21st September 2020

After a break for a year, we are planning another day's golf at The Downs Course, Goodwood.

The idea, as before, is to raise funds for the Foundation which was set up at Arundel over 30 years ago. Our two main objectives are:

- the welfare and encouragement of young people from inner city environments, to give them space in which to play and have fun, and opportunities to enhance their lives through a carefully constructed programme of activities
- to assist with the development of young people with special educational needs and many disabilities besides. A day out at Arundel with its castle, gardens, seaside and free spirit makes the world of difference to those confined by disadvantage and often deprivation.

Over the years, many thousands of young people have already benefited from this project in all sorts of different ways. We intend to ensure that a great many more will have the chance to take advantage of the outstanding facilities and staff at Arundel in the future.

This is where you come in – might you be interested in joining us or even perhaps bringing a team? We would be so grateful, and so would the youngsters. The details of the day are attached with this letter. The entry fee is £150 per player or £600 per team of four players. This will include an 18-hole Texas Scramble competition, coffee and bacon rolls on arrival, refreshments at the Halfway Hut, plus a two-course lunch (excluding wine) at The Kennels afterwards. In order to help speed up play, we are encouraging the hire of 2-man Woody Buggies which Goodwood have kindly agreed to offer at a special discounted rate.

You will see that we have decided to abandon both auction and raffle which have become something of a distraction and perhaps even an irritation in the past. We shall simply invite participants to pledge money, if they wish, as a donation to the Foundation and so give everyone the greatest possible opportunity to lend support to an imaginative and important scheme from which enormous social benefit is derived for the young, their teachers and carers.

It is a somewhat different approach for which I hope you will share our enthusiasm and intention to maximise the potential and enjoyment of the day. The occasion stands to make a very real difference to those for whom life is a considerable struggle. Do hope you can come!
